

Pressure mounts on India to stop genocide against Muslims



Amnesty International has called on the Indian government to immediately end a "vicious" crackdown on Muslims who took to the streets to protest against anti-Islamic comments made by two members of Prime Minister Narendra Modi's Hindu nationalist Bharatiya Janata Party (BJP).

Authorities have been accused of "selectively and viciously cracking down on Muslims who dare to speak up against the discrimination faced by them," Amnesty International's Aakar Patel said in a statement.

"Cracking down on protesters with excessive use of force, arbitrary detention and punitive house demolitions is in complete violation of India's commitments under international human rights law."

Many Muslims were killed and hundreds of others arrested last week in nationwide protests over the comments, which embroiled India in a diplomatic furore and caused widespread outrage in the Muslim world. Amnesty demanded an "immediate and unconditional release" of the jailed protesters.

Also, in a letter to the chief justice of India's Supreme Court, six prominent former judges and six senior lawyers said the government in Uttar Pradesh state had acted illegally by bulldozing the home of a Muslim activist following the protests.

S_{tate} chief minister, Yogi Adityanath, a saffron-robed BJP hardliner, ordered the weekend demolition of any illegal buildings of people accused of involvement in violence, including the home of activist Mohammad Javed.

Adityanath, one of India's most prominent Hindu nationalist politicians, is known for his sectarian rhetoric against India's 200-million strong Muslim minority.

He has repeatedly called on authorities to demolish the homes of people accused of crimes, an exhortation critics say violates constitutional and human rights laws that ban collective punishment.

The former judges and lawyers urged the Supreme Court to take action to "arrest the deteriorating law and order situation" in Uttar Pradesh.

"The coordinated manner in which the police and development authorities have acted lead to the clear conclusion that demolitions are a form of collective extrajudicial punishment, attributable to a state policy which is illegal," they wrote.

Local officials said the demolition was

justified as parts of the house had been illegally constructed and that Javed had not appeared for hearings on the issue in May. Uttar Pradesh police said Javed was also involved in the violence during one of the recent protests.

But Javed's 24-year-old daughter Afreen Fatima, also a prominent activist, said the family had not participated in the Friday protests in the city. She also rejected the city administration's allegations that their house was illegally constructed.

"We had been paying our house taxes for around 20 years and not once did we receive any intimation by any development authorities that our house is illegal. Why were they even taking our taxes if it was an illegal house?"

K K Roy, Javed's lawyer, said the building was owned by Javed's wife and not him: "Under the Muslim Personal Law Property Act, the husband cannot have a share in the property of his wife. Since Javed has no right over the property as per law, the notice in his name is illegal. We have challenged the notice and sought a penalty of at least 10 crore rupees (\$1.3m)," he said.

Amnesty's Aaker Patel said the arrests

and demolitions were "part of an alarming escalation of the states' measures targeting Muslims."

In the United States, a Muslim member of the House of Representatives called for the American State Department to declare India an egregious violator of religious freedom.

Ilhan Omar, abled a resolution that has been co-sponsored by Representatives Rashida Tlaib, Jim McGovern and Juan Vargas, all Democrats. Omar and Tlaib are the first Muslim American women in Congress and they have both tended to focus on, among other things, Muslims around the world and threats and challenges confronting them.

The resolution, which is non-binding unlike a legislation, calls upon Secretary of State Antony Blinken to designate India a "country of particular concern", a categorisation used by the US under its International Religious Freedom Act for countries it considers are the most egregious violations of religious freedom.

"The Indian government must be held responsible for human rights violations against religious and cultural minorities," Omar said.

Imam confirms Islamic Literature Collection service is compliant with Sharia Law

A prominent imam has confirmed that a Blackburn businessman who went viral after he was confronted by several men whilst collecting sacred Islamic text, is correctly disposing of all items in accordance with Shariah law.

Mufti Abdullah Bismillah, Imam of Noorul Islam Masjid in Blackburn, confirmed in an e-mail to Paigaam that he had personally inspected the work undertaken by Hafiz Mehboob Daud and he was satisfied that the work met all the essential criteria, as ccording to Islamic tradition, it is unacceptable to throw away Qurans and other Islamic literature; books must be buried.

"I have inspected the work undertaken by Islamic Literature Collection and can confirm all items are correctly disposed of in accordance with Shari'ah law," said Mufti Abdullah.

"I will continue to monitor the work undertaken by them to ensure all items are dealt with correctly."

He also explained the rationale behind verifying Hafez Mehboob's work.

"To elaborate on my statement that "Islamic Literature Collection have been disposed of according to Shariah law, the Islamic Literature Disposal organisation receives Qurans, Mus'hafs, Islamic kitabs (Arabic, Urdu and English), worn out books and papers, and frames from the general public.

"These are the steps taken to dispose the materials received. The Quran, kitabs, papers and frames are separated into different bags. If there are Qurans, kitabs or frames that can be restored, they are put aside and redistributed if possible. Biodegradable materials (Quran and Mus'hafs) that cannot be recycled are subsequently buried. Kitabs, papers and other materials, which are deemed to be non-biodegradable are incinerated; their ashes are then buried."

The Islamic Literature Service, which Hafiz Mehboob heads, travels to locations across the country and people can hand over their old books and other scared texts for safe disposal or redistribution. For this, the organisation charges £2.50 per kg.

Paigaam reached out to Hafez Mehboob, who confirmed, Mufti Abdullah was the "gatekeeper" in terms of ensuring his service is compatible with Islamic law.

"We provide a public service for Muslims throughout the UK. Mufti Saheb has verified out work, and as the gatekeeper, you cannot get any more proof that that."

Hafez Mehboob also elaborated on why he was coy in relation to explaining to the men, in the video, where the sacred texts are buried.

"We cannot tell you where we bury the literature as that is a confidential aspect of our business. However, we can confirm that we used a plot of land and that everything is disposed off in the correct way, according to shariah."

He also confirmed, good copies of the Holy Quran are made available to people to take away, should they feel the need to distribute them to poor people within the locality, or internationally: "People do take copies of the Quran and other literature if they need them or want to give them away to people who can use them. People like Blackburn Councillor, Tiger Patel, along with Mufti Saheb and many others vouch for us, so please pray that our efforts are accepted."

In a TikTok video shared extensively and posted this week, a man can be seen asking Hafez Mehboob what he does with sacred texts.

He asked: "You provide a public service to the Ummah and you charge a fee. What do you do with the collections?"

Hafez Memboob said it goes for "sorting, redistribution and burial", and the worker attempts to further explains the process.

Not content with the answer the man, who provides a similar service from Halifax, asks "where it is buried?" to which Hafez Mehboob says he is "unable to divulge and he has "nothing to hide" and says his organisation tells people "if you trust us then use the service."

Hajj booking fiasco results in many British Muslims losing out

British Muslims hoping to partake in the 2022 Hajj pilgrimage are at risk of losing thousands of pounds after the Saudi government announced European, Australian and American travellers are now subject to an online booking service.

Pilgrims have been told to use a website to register their interest and that a draw will then determine who will go on Hajj.

However, those who have already booked with Hajj tour operators could potentially lose thousands of pounds, after the Saudi government advised that anyone who has not booked for the 2022 Hajj via the Motawif web site by the 13th of June would not be allowed to partake in the pilgrimage.

It is also unclear how many Hajj visas will be allocated to the UK. Previously about 25,000 were issued every year.

The portal offered a range of flight and accommodation packages. However, these Saudi government packages did not benefit from ATOL. It's fair to say that the Hajj experience is now for the middle class and the rich. It's now all about five star luxury, the closeness of the hotels and whether there's a restaurant, Oud shop or jewellery outlet even better.

The Saudi's by launching the new portal had the perfect opportunity to make a bold statement. The price of Hajj could have been capped to ensure people from all walks of life could fulfil their religious obligations.

Sadly, they have done the opposite as the cost of Hajj now varies from about £6,000 to more than £10,000 and many Muslims spend years saving up for it.

The head of the All Party Parliamentary Group on Hajj and Umrah, Yasmin Qureshi, has written to the Minister of Hajj and Umrah, Tawfiq bin Fawzan Al-Rabiah to ask for the new system to be delayed until next year.

Ms Qureshi has asked if money paid to Saudi service providers will be refunded. She has also said she is worried that Muslims who had deferred their trip in 2020 risk major financial losses if their pilgrimage is not carried out.

She is also concerned about how and if pilgrims' money will be protected under the new scheme.

Ms Qureshi said: "Certainly for this year, do not organise the portal system because it's not going to work. Who do you complain to if things don't turn out correctly?"

There are 3.72 million Muslims in the UK according to figures from Office for National Statistics. All pilgrims from Europe, America and Australia must use the new online portal to book their pilgrimage.

Paigaam has contacted the Licensed Hajj Organisers UK, an independent industry watchdog, and the Council for British Hajjis UK for a comment. The Saudi government has also been asked to comment.

The Saudi authorities have not confirmed the process for Hajj 2023.

It occurs at a time when the governing body remains in the spotlight for its failure to act when Azeem Rafiq first made his racism allegations against Yorkshire almost two years ago.

A subsequent 12-point action plan to improve inclusion at all levels was

eventually unveiled by the ECB in November, but only after Rafiq had appeared in front of a parliamentary panel and laid bare the full scale of the problem cricket was facing with discrimination more than a year after his initial claims had gone public.

This link with Nujum Sports is aimed at helping ensure the needs of Muslim players are focused on from grassroots level all the way to the top of the elite game.

The ECB said it wanted to "listen to the insights of Nujum".

Kate Miller, the ECB's chief diversity and communications officer, said: "Over the last year, Nujum Sports has assisted the ECB, particularly in preparing for Ramadan, helping us to support many clubs and players with practical advice and guidance.Ensuring that cricket is open, inclusive and accessible for people of all faiths is critical to us.

"Working with organisations like Nujum will allow us to learn more, connect better and challenge ourselves to continually improve our work in equity, diversity and inclusion."

Nujum Sports, founded in August 2020 by former Football Association officer Ebadur Rahman, was set up with the aim of ensuring Muslim athletes have every opportunity to fulfil their potential.

In 2021, it devised the Muslim athletes charter, a 10-point framework through which clubs can assess whether their facilities and practices cater adequately to Muslims.



Catalonia & South Africa recognise 'crime of apartheid'



he parliament of the Catalonia region in Spain has become the first in Europe to acknowledge the crime of apartheid committed by Israel against the Palestinian people.

Catalonia's regional parliament on Thursday formally recognised that Israel is committing the crime of apartheid against the Palestinian people.

Lawmakers in the autonomous Spanish region passed a resolution accusing Israel of overseeing a system that is "contrary to international law and is equivalent to the crime of apartheid as defined in the Rome Statutes of the International Criminal Court, Article 7.2 (h)".

This makes the parliament in Catalonia the first in Europe to publicly acknowledge Israel's imposition of apartheid, which has also been widely documented by international rights groups including Human Rights Watch and Amnesty International.

MP Susana Segovia, a Catalan politician,

activist, and current spokesperson for the left-wing party Catalunya en Comú called it a "historic moment".

"Today we call by name the violation of human rights in Palestine."

The resolution, first tabled in March, called on Catalonia's autonomous government and the central Spanish government to use all their political and diplomatic tools to hold Israel to account for its systematic rights abuses against Palestinians.

It also demanded that human rights are put at the heart of bilateral and multilateral agreements with official Israeli institutions.

"We hope that their courageous vote will inspire other regional parliaments of the Spanish state, as well as its state parliament, to also stand on the right side of history," the Palestinian Boycott, Divestment (BDS) movement said in a statement released Thursday.

The global BDS movement is a solidarity campaign calling for the isolation of

Israel in response to its crimes against Palestinians, which include illegal occupation of Palestinian territory, denial of the right to self-determination, forced expulsions, seizures of land and property, and unlawful killings.

In addition, South African Foreign Minister Naledi Pandor urged the international community to take action to put an end to grievances of the Palestinians under Israeli occupation.

"As South Africans, we find similarities in our past with the Palestinians," Pandor said in her speech before a UN conference on the rights of the Palestinians.

"It reminds me of the gravesites that we had to carry out under the persecution of the apartheid soldiers."

Palestinian officials also welcomed a resolution passed by Catalonia's regional parliament condemning Israel's crime of apartheid against Palestinians. They termed the resolution as a "victory for the just Palestinian cause" and exposes "the true face of the Israeli occupation and its indifference to international laws."

Imam blasts Government after being sacked as adviser

imam at the Makkah Masjid in Leeds, who was dismissed as a Government adviser after he gave his backing for a campaign to prevent cinemas from screening a film purportedly about the noble Fatima Az Zahra (R.A.), has said an assertion, he acted to spread religious hatred is "inaccurate".

Qari Asim said he learned about a letter from the Department of Levelling Up, Housing and Communities (DHLUC) informing him that he had been removed from his roles as an independent adviser and deputy chair of the Government's Anti-Muslim Hatred Working Group through the media.

The imam was appointed as an adviser in independent 2019 to provide expert advice on a definition of Islamophobia to the Government. In a statement, the DHLUC said in its letter it had "no option" but to revoke Mr Asim's role with "immediate effect".

"Your recent support for a campaign to limit free expression - a campaign which has itself encouraged communal tensions - means it is no longer appropriate for you to continue your work with Government in roles designed to promote community harmony," the department said.

In its letter, the DHLUC added: "You will have no doubt seen reports of the scenes outside different cinema venues. These included deeply disturbing videos of sectarian chanting and anti-Shia hatred.

"As you know, anti-Shia hatred is a longstanding and very serious issue, which must be challenged at every opportunity as part of a wider effort to combat anti-Muslim hatred.

"We were disappointed to see that you failed to condemn some of the protests complicit in these behaviours.

However, Mr Asim said the contention made in the DHLUC's letter that he had acted to undermine democratic values or spread community tension and religious hatred was "inaccurate".

In a letter to Levelling Up Secretary Michael Gove, Mr Asim said he fully understands and supports the values of free speech.

However, he believes there is also a "nuanced and complex debate" around "boundaries and limits."

He said: "I am of the firm opinion that the challenge to and critique of the 'Lady Of Heaven' film is part of free speech, though violence and intimidation can never be."

This was because he did not "personally attend or organise any protests outside any cinemas" regarding the film, adding that his "strong preference is always dialogue. I did, however, support people's democratic right to protest," he added.

Kirklees Council leader Shabir Pandor set to 'run for MP'

he leader of Kirklees Council, Shabir Pandor, is said to be one of the contenders for Huddersfield MP Barry Sheerman's seat when he steps down.

In December, the 81-year-old Labour MP confirmed that he would not be standing at the next General Election - expected to be around two years away.

Given that Mr Sheerman has held the seat for 40 years it is a plum target for any aspiring politician and given his prominence in Huddersfield Labour circles the 56-year-old is likely to be a strong challenger. Clr Pandor is one of shortlist that will be voted on by the 550 seven Labour hopefuls with an eye on taking over from Mr Sheerman, who is to step down at the next general election.

The others are his fellow councillors and Cabinet members Mus Khan and Naheed Mather, who both represent Dalton ward in Huddersfield; lawyer Hugh Goulbourne; former Ashbrow councillor Harpreet Uppal; former York councillor Iames Flinders: and trade unionist Mark Morris.

All seven have made the longlist to find the party's next candidate. That number is expected to be whittled down to form a members of Huddersfield Constituency Labour Party. A final selection is expected in July.

Her family was so bereft of all material possessions that they did not even have oil to light a lamp or a piece of cloth to wrap her up in.

And with her first night in the world, the Holy Prophet, peace be upon him, appeared in her father's dream saying:

"Your newly born daughter is a favorite

of the Lord, and shall lead many people to the right path."

After being orphaned during a famine, she fell into the hands of slavery. Upon finishing her chores tirelessly during the day, she would hold night-long vigils Not only was she distant from people but was also devoid of any material possessions. Her biographers claim that when she passed away, she had nothing but a prayer mat, a pottery jug, and a bed that doubled as her prayer rug.

It was this airy and light existence that allowed her to lead a nomadic life. It has been said that she once embarked on a pilgrimage to Makkah on foot which was to take seven years at the time.

> Her identity was multifaceted: she was pious, she was a poet, with excerpts of her poetry existing today, though, are perhaps as scarce as her material belongings.

Not only did she renounce worldly luxuries but also any form subservience to any being.

Her only allegiance was to her Lord. And that servitude ironically was the greatest source of liberation for her.



Life-saving lung scans offered

People living in the Spen^{*} area of North Kirklees are being targeted as part of a multi-million-pound programme which is saving lives through early lung cancer diagnosis.

More than 2,000 people have already been checked for signs of lung cancer since the programme began in North Kirklees in December.

The checks have so far identified 19 patients with suspected cancer and resulted in others being referred for further investigation.


People aged 55 - 74 who smoke or have ever smoked, and are registered with a GP in the area, will be invited for a health check with a specially trained nurse. The check will take place over the 'phone and last around 20 minutes.

If any issues are found during the health check, people will be offered a CT scan at a mobile scanner unit, located in the car park of the Tesco superstore in Cleckheaton.

This phase of the programme will see a further 5,500 people invited to attend the life-saving health checks.

Dr Khalid Naeem, GP and Chair of NHS Kirklees Clinical Commissioning Group, said: "Lung health checks have a vital role to play in the fight against cancer.

"They can help find problems early, often before you notice anything is wrong,



and at a stage when treatment could be simpler and more successful.

"Most lung cancers grow slowly enough for them to be found at an early stage by a lung scan – so this programme will ultimately save more lives."

Debra Colleran, a patient at Cherry Tree GP Surgery in Batley, says taking part in the programme gave her vital peace of mind.

She said, "I stopped smoking 15 years ago but had previously been an active smoker for about 15 years before that. It's an extremely important subject and I'm delighted to have been able to take part.

"The nurse was very helpful and explained everything to me. The results that came back have certainly put my mind at rest."


Debra's assessment indicated that she did not need a CT scan.

Debra added, "I'd encourage anyone who gets the chance to take part in this programme to accept the invitation."

Programme lead for Kirklees CCG, Marion Redford, said, "Even if you feel fit and well, or gave up smoking years ago, it's really important that you attend a lung health check when you're invited.

"Lung cancer is the most common cancer in West Yorkshire and is directly related to smoking and tobacco use.

"There are often no signs or symptoms of lung cancer at an early stage. As a re-



sult, sadly around 7 in 10 cancer patients are currently being diagnosed too late to be cured."

She added, "We've done everything possible to make the health checks as convenient as possible. The initial appointment is by telephone and people who need a CT scan will be invited to attend the mobile scanner in Cleckheaton rather than a local hospital."

North Kirklees is one of 23 Lung Health Check pilot sites which are contributing towards reaching the NHS Long Term Plan ambitions of catching thousands more cancers at an earlier stage when they are easier to treat.


Across England, around 600 cancers have been diagnosed early so far, giving patients a much better chance of beating the illness.

The programme is supported by the West Yorkshire and Harrogate Cancer Alliance and has been funded by NHS England as part of a national pilot designed to improve early diagnosis and treatment of cancer.

North Kirklees GP federation, CURO Health, are delivering the Targeted Lung Health Check Programme in Kirklees. In total, there are around 19,000 people in North Kirklees who are eligible for a health check.

t is undeniable that one of the most traumatic and painful experiences people suffer is during the loss of a close family member.

It's an awful gut-wrenching experience. Nothing can prepare for that moment even if you've known for some time that the end is approaching. In the grip of grief, some have said that they feel frozen in a seemingly eternal present.

During those painful moments of grief, faith plays a great role for Muslims in bringing some semblance of meaning and understanding to what had just happened.

Of course, the process after the death for us requires urgency and swiftness - the funeral and burial has to be done with immediate effect as the Hadith of the Prophet (pbuh) stated that, 'Hasten the burial rites' (Bukhari).

During the beginning of Covid-19, many lives were lost across the world. Unfortunately, mortality rates had also increased across our local communities.

Muslim Chaplains working at As Mid Yorkshire Hospitals, they have experienced an unprecedented number of

bodies became overwhelming for staff, and therefore as per our commitment to personalised care, which focuses on the beliefs and spiritual needs of individuals, the Trust decided to review the out-ofhours service in accordance with Trust's vision of achieving excellent patient experience each and every time.

Due to the disproportionately high number of BAME deaths in the county, the Trust decided to train the Muslim Chaplains to deal with the processes of certification of death etc during out of hours.

38 killed on smart motorways in five years

hirty-eight people have been killed on smart motorways in the last five years, the first time that the total number of deaths has been reported.

Smart motorways have been criticised because they do not have a hard shoulder and drivers who break down can be trapped in the speeding traffic.

The network is facing an overhaul with the results of a government review due to be announced shortly. A Freedom of Information (FoI) request sent to Highways England revealed that on one section of the M₂₅, the number of near misses had risen 20-fold since the hard shoulder was removed in April 2014. In the five years before the road was converted into a smart motorway there were just 72 near misses. In the five years after, there were 1,485.

A "near miss" is counted every time there is an incident with "the potential to cause injury or ill health".

The FoI request also revealed that one warning sign on the same stretch of the M25 had been out of action for 336 days. The idea behind smart motorways was to improve the flow of traffic through the most congested parts of the network by using the hard shoulder as an extra lane. There are currently 200 miles of smart motorway and another 300 miles are due to be converted by 2025.

There are around 90 deaths per year on the UK's motorway network as a whole, which covers about 2,300 miles of road. Transport Secretary Grant Shapps said he wants to fix smart motorways because they are too confusing for drivers. He said: "We absolutely have to have these as safe or safer than regular motorways or we shouldn't have them at all."

A government review, the results of which are due to be announced shortly, is expected to recommend reforms to improve safety.

Legal Column Trade Union Targeted by Social Media Campaign Awarded £50,000 Damages

o matter how strongly you may feel, you should think very carefully about posting on social media. As a High Court ruling showed, expressions of regret after the mouse/ email has been clicked may not be enough to save you from the serious legal consequences of descending into libel or harassment.

The case concerned a man who used social media to mount a persistent campaign of denigration against a branch of a trade union.

Without any evidence, he made incendiary and scurrilous allegations concerning the branch, asserting, amongst other things, that it was controlled by a criminal group.

The union brought libel and harassment

proceedings against him, and he accepted during the COVID-19 pandemic when that the posts were totally unacceptable and apologised for any distress caused. He cited his diabetes and associated mood swings and assured the union that the posts had been removed. A judge, however, upheld the union's case in its entirety on the basis that he had no viable defence to the claim.

Following a further hearing, the Court noted that the man's allegations had gained a lot of publicity, through the internet. The harm to the good name of the union and the branch was clear in that they depended on their reputation for integrity and performance in negotiations to attract and retain members.

The court awarded £50000 damages to the Union. The Court noted that the posts had the character of a coherent and persistent campaign and were published trust in the union was at a premium. They caused anxiety and uncertainty amongst workers at a time.

The Court noted that the purpose of the award was to vindicate the union. It sent out a public message that would restore its good name and convince bystanders of the baselessness of the man's allegations. The Court also issued an injunction which forbade him from publishing any similar allegations in the future.

What Is A Controversial Application? Guidance From the Court.

However, as a court has shown, the fact that objections may, in effect, come from a single source is relevant to the question of whether a proposed development should be viewed as controversial.

The case concerned a planning consent granted for a night shelter for the homeless in a listed building, another part of which was occupied by a dance studio. A total of 26 objections to the application were received, all but one of which related to the development's impact on the studio and its customers.

Concerns were expressed that difficulties

would be caused to dance students, some of them children, by homeless people congregating outside the studio and that homeless people resorting to the shelter would find it difficult to sleep so close to a business that played music late at night.

The consent was granted by a planning officer, using delegated powers, on the basis that the proposal was unlikely to be of a controversial nature. The studio contended that, given the number of objections, that view was irrational.

In mounting a judicial review challenge to the consent, it stated that the application should have been referred to the council's development control committee for consideration.

Rejecting the studio's complaints, however, the Court observed that there is nothing inherently controversial in the provision of accommodation for homeless people.

In assessing whether the application was controversial, the officer was entitled to have regard to the identity of the objectors and to the possibility that their opposition may have been sought or encouraged by the studio.

Any such encouragement did not indicate that the objections were insincere, but the Court observed that it might well indicate that the people concerned may not have felt strongly enough about the matter to object of their own accord. The officer was entitled to conclude that, rather than being controversial, the application was of interest only to a narrow group of people.

૯ ઝુલ હિજ્જહની ફજરથી લઈ ૧૩ ઝુલ હિજ્જહની અસર સુધી કુલ ૨૩ ફર્ઝ નમાઝો પછી તકબીરે તશરીકના મુબારક દિવસો હોય છે. જેમાં મસ્જિદોના અંદર ઉપરોક્ત ૨૩ ફર્ઝ નમાઝો પછી દરેક મુસલ્લી હઝરાત ઉંચા અવાજથી તકબીરે તશરીક પઢે છે. અને ઓરતો પોતાના ઘરોમાં આ દિવસોમાં ધીમી અવાઝથી તકબીર પઢે છે. તકબીરે તશરીક મર્દ ઓરતો બન્ને માટે પઢવું વાજીબ છે. મસ્બુક જેની રકાતો છૂટી ગઈ હોય તેના માટે પણ પોતાની છૂટેલી રકાતો પૂરી કરી ધીમી અવાઝથી તકબીરે તશરીક પઢવું વાજીબ છે. આ વાત ખાસ યાદ રાખવા જેવી છે. ઓરતોએ પણ પોતાના ઘરોમાં ઉપરોક્ત દિવસોમાં ૨૩ ફર્ઝ નમાઝો પછી આ તકબીર પઢવું ભૂલવું જોઈએ નહીં.

કેટલીક મસ્જિદોમાં આ વાજીબ તકબીરે તશરીક બિલ્કુલ ધીમા અવાઝથી ઓરતોના જેમ પઢે છે એ સહી નથી. નમાઝી ભાઈઓએ શરમાવું જોઈએ નહીં. જરા અવાઝથી મર્દીના જેમ પઢવું વાજીબ છે. આ તકબીરે તશરીકમાં પ્રથમ ભાગ હઝરત જીબ્રઈલ અલે.નો છે. જ્યારે કે, જન્નતથી ડુમ્બા(જાનવર) લઈને આવી રહ્યા હતા વચ્ચે દરમ્યાિનનો ભાગ હઝરત ઈબ્રાહીમ અલે,નો જ્યારે છેલ્લો ભાગ હઝરત ઈસ્માઈલ અલે.નો છે. તકબીરે તશરીક પઢતી વેળા આ ધ્યાનમાં રાખવા જેવું છે અને અગર ઈમામ પઢવાનું ભૂલી જાય તો પણ મુક્તદી હઝરાતે પઢવાનું શરૂ કરી દેવું જોઈએ. ઈદ્લ અદહાની વાજીબ નમાઝ પછી પણ તકબીરે તશરીક પઢવું વાજીબ છે. એ હિસાબે કુલ ૨૪ નમાઝો થશે.

ર્શદેલ અદહાઃ

૧૦ ઝુલ હિજ્જહ ઈદુલ અદહાનો મુબારક દિવસ છે. આ મુબારક દિવસે પણ પોતાના પાસે જેટલા કપડાં છે તેમાં સૌથી સારાં (નવા જેવા) કપડાં પહેરવું જોઈએ. ઘણાં ભાઈઓ નિકાહ અને વલીમાંના દિવસે તો નવાં કપડાં પહેરે છે પરંતુ ઈદ જેવા અતિ મહાન અને મુબારક દિવસોમાં એનો એહતેમામ કરતા નથી. શાદી અને વલીમાના દિવસો ઈદના મુબરક દિવસ કરતા મહાન નથી.

કુરબાનીના દિવસો :

૧૦ ઝુલ હિજ્જહથી લઈ ૧૨ ઝુલ હિજ્જહ એમ ત્રણ દિવસ કુરબાનીના છે. એક કુરબાની જે દેશમાં રહો છો ત્યાં પણ જરૂર કરવું જોઈએ. આજકાલ લોકો જ્યાં સસ્તી કુરબાની થતી હોય છે ત્યાં કરાવે છે. શાદીઓમાં ખર્ચ કરતી વેળા પૈસા જોતા નથી પરંતુ કુરબાનીના સમયે હિસાબ કરે છે. એક બકરાની કુરબાની પોતાના ગામમાં પણ કરાવવું જરૂરી છે. જેથી પોતાના ગામના ગરીબો પણ બકરાની કુરબાનીનું ગોશ્ત ખુશી ખુશી ખાય શકે. ઈંગલેન્ડ અને ઈન્ડિયામાં મોટા મોટા ફ્રીઝોએ બધાને કંજુસ બનાવી દીધા છે. માલદારો સારૂ ગોશ્ત પોતાના ફ્રીઝમાં ભરે છે અને હાડકાવાળું ગોશ્ત ગરીબોને વ્હેંચે છે. એ તો ઈન્સાફ નથી જ. આ વર્ષે દરેક મુસ્લિમ ભાઈ બહેનોને નમ્ર વિનંતી છે કે, ઉપરોક્ત સાચી હકીકત પર ધ્યાન આપે અને દરેક પોતાના ગામના ગરીબો અને મધ્યમવર્ગના લોકોનો પૂરો ખ્યાલ રાખે અને બકરાની કુરબાની કરાવી તેમને ગોશ્ત પહોંચાડે.

મહેમાનીના દિસો :

વર્ષના ૩૬૫ દિવસોમાં પાંચ દિવસ મહેમાનીના દિવસો હોય છે. જેમાં રોઝા રાખવું હરામ છે. એક ઈદુલ ફીત્રનો દિવસ એક ઈદુલ અદહાનો દિવસ અને ઈદ પછીના ૧૧.૧૨.૧૩ ઝુલ હિજ્જહના દિવસ.

હજના દિવસો :

૮ ઝુલ હિજ્જહ હાજીઓ મીનામાં હોય છે. એને યવમુત્તર્વિયહ કહેવામાં આવે છે. ૯ ઝુલ હિજ્જહ એ હાજીઓ માટે અરફાનો મુબારક દિવસ હોય છે. જે હજનો મહત્વનો દિવસ હોય છે. ૧૦ ઝુલ હિજ્જહ ૧. શયતાનને કાંકરા મારવા ૨. હલક કરાવવું કુરબાની કરાવવી અને તવાફે ઝિયારત કરવું. બાકી દિવસોમાં પણ ત્રણ શયતાનને કાંકરા મારવામાં આવે છે અને મીનામાં કયામ કરવામાં આવે છે. હજના આ પાંચ દિવસનો રોમાંચ કંઈક અલગ પ્રકારનો જ હોય છે. મસ્જિદે હરામ મક્કાની પવિત્ર મસ્જિદમાં નમાઝની અદાયગીનો સૌથી વધુ સવાબ છે છતાં પણ હજના આ દિવસો જેમાં પ્રથમ મીનામાં કયામ અને ૯મી ઝલ હિજ્જહના અરફાતના કયામનું મહત્વ અને સવાબ વધુ હોય છે.

અંતમાં ઝુલ હિજ્જહના મુબારક દિવસો અને એની ફઝીલત આપણા સૌને નસીબ થાય એવી દુવા કરીએ છીએ. ઝુલ હિજ્જહના હજ અને કુરબાનીના આ દિવસો ખૂબજ અગત્યના છે. વળી ઈસ્લામના પાંચ ફરજોમાં હજ પણ ફર્ઝ છે જે દરેક મુસલમાન જેના પાસે એટલી માલી તાકાત છે તેણે પૂરી કરવાની હોય છે.

આપવા માંડ્યા પણ તમે કહ્યું આજનું ખાતું બંધ થઈ ગયું છે. હું કંઈ સમજ્યો નહીં. ત્યારે હકીમની બાજુમાં બેસેલી વ્યક્તિએ કહ્યું હકીમ સાહેબ આવે છે ત્યારે રોજના ખર્ચની ચિઠ્ઠી મૂકે છે. તેટલી રકમ મળતા દવાખાનું બંધ કરી ઘરે ચાલી જાય છે અને અલ્લાહની ઈબાદતમાં મશગુલ રહે છે. આ સાંભળી મને યકીન થઈ ગયો કે, તેમની દવામાં જરૂર અસર થશે. ઘરે જઈ મેં મારી બીવીને તમામ હકીકત દર્શાવી. તેણે કહ્યું અલ્લાહનો જરૂર નેક બંદો હશે. દવાનો વપરાશ પછી હું આજે ત્રણ છોકરાનો બાપ છું. હું જ્યારે આ દેશમાં આવું છું ત્યારે તમને મળવા આવું છું પણ દવાખાનું બંધ હોય છે. આજે કોઈએ કહ્યું તેમને મળવું હોય તો સવારે જ આવી જવું.

હું યુ.કે. સ્થાયી થયો છું. દર વર્ષે મારી બહેન અને તેની ફેમિલીને મળવા આવું છું. હું હાલમાં મારી ભાષોજની શાદી માટે અહીં આવ્યો હતો. તેની શાદીનો તમામ ખર્ચ મારા શીરે હતો. હું તમામ ખરીદીમાં મશ્ગુલ હતો. મામલો કંઈક એવો બન્યો કે, શાદીની તમામ તૈયારી થઈ ગઈ હતી અને મારી ભાણેજને તાવ આવ્યો. બીમારી ગંભીર થતી ગઈ અને એકાએક તેનો ઈન્તેકાલ થઈ ગયો. હું અને મારી પત્ની બેસીને વિચાર કરતા હતા કે શાદીની તમામ વસ્તુઓ ખરીદાઈ ગઈ છે હવે એનું શું કરવું ? અને ત્યારેજ મારૂં ધ્યાન તમારા ઉપર ગયું. ૧૬વર્ષ પહેલાં જ્યારે હું તમારી પાસે આવ્યો હતો ત્યારે એક નાની છોકરી તમારા પાસે ઊભી હતી અને કહી રહી હતી કે બાબા મને ભૂખ લાગી છે ઘરે ચાલો. મારી બીવીએ કહ્યું કેમ ન આપણે હકીમ સાહેબ પાસે જઈએ અને આ બધો સામાન તેમને ગીફ્ટ કરી દઈએ જે તેમને તેમની છોકરી જે હવે શાદી લાયક થઈ હશે તેના માટે કામ લાગશે. તમે મને જરા પણ મના કરશો નહીં. હું મોટી ઉમ્મીદ લઈને આવ્યો છું.

આ વાત સાંભળી હકીમ સાહેબની આંખોમાથી આંસૂ વહી રહ્યા હતાં. તેમણે રડતાં રડતાં ગજવામાંથી ચિઠ્ઠી કાઢી અને તે માણસની સામે મૂકી કહ્યું, ભાઈ સાહેબ જુઓ આજે જ મારી બીવીએ ધરના જરૂરિયાતના સામાનની સાથે બેટીની જહેજની હકીકત લખી અને જૂઓ તેની નીચે મેં શું લખ્યું. અલ્લાહનું કામ છે અને અલ્લાહ જ પૂરું કરશે. મેં આ વાત લખી મામલો બંધ કરી દીધો હતો. પરંતુ મારા રબની કરીમી જૂઓ કે આજે હું અહીંથી ઉઠ્યો જ નથી કે, મારા રબે આ તમામ કામનો એહતેમામ (બંદોબસ્ત)કરી દીધો. હકીમ સાહેબે પેલી વ્યક્તિને કહ્યું મને તમારી ભાણેજની મોતનો સદમો જરૂર છે, પરંતુ હું મારા રબની કુદરત પર હેરાન છું કે, આજે હું મારા ઘરે ખાલી હાથ ન જઈશ.. કહે છે કે, જેનો અલ્લાહના ઉપર ભરોસો મજબુત થઈ જાય, તવક્કુલ મજબુત થાય તો અલ્લાહ જરૂર મદદ કરે છે. હલાલ કમાઈએ, રોજીની તમન્નામાં અલ્લાહ ગમોને દૂર કરે છે.

ચાલો આજે આપણે એક પરહેઝગાર હકીમની વાત જાણીએ

એક શહેરમાં હકીમ પોતાનું દવાખાનું ચલાવતા હતા. જ્યારે સવારે પોતાના કામ ઉપર જતાં ત્યારે તેમની પત્નીને કહેતા, આજે તને ઘરની જે જરૂરિયાત છે તેનું લીસ્ટ બનાવી મને આપી દે. બીવી જરૂરિયાતની વસ્તુનું લીસ્ટ બનાવી હકીમ સાહેબની આપી દેતી. હકીમ દવાખાને પહોંચી પત્નીએ બનાવેલ લીસ્ટની સામે વસ્તુઓની કિંમત લખી દેતાં અને ટોટલ કરી દેતા. પછી અલ્લાહથી હાથ ઉઠાવી કહેતા કે યા રબ હું મારી ફેમિલીના ખર્ચાઓને લીધે આ જગ્યાએ હાજર છું અને તારી ઈબાદત છોડીને અહીં આવ્યો છું કે મારા ઘરનો આ ખર્ચ પૂરા થાય જે મારી જીમ્મેદારી છે. આ ખર્ચ પૂરો થતાં હું દુકાન બંધ કરી તારી ઈબાદતમાં મશ્ગુલ થઈ જઈશ. અને આ રીતે તેનો મામલો દરરોજ ચાલતો રહેતો હતો.

દર્દીઓને જોવાનું કામ પૂરૂં થવાનું જ હતું કે તેમના દવાખાનાની સામે એક મોટી કાર પાર્ક થઈ અને તેમાંથી ખુબસુરત લિબાસ પહેરેલ એક વ્યક્તિ બહાર નીકળ્યો અને દવાખાનામાં દાખલ થયો. દર્દીઓને દવા આપવાનું કામ પૂરૂં થયે પેલી આવેલ વ્યક્તિને કહ્યું, સાહેબ તમને દવા જોઈતી હોય તો મારી પાસે આવી જાઓ હું ચેક કરીને તમને દવા આપી શકું. પેલી વ્યક્તિએ કહ્યું હકીમ સાહેબ તમે મને ઓળખ્યો નહીં ? અને હાં તમે ઓળખી પણ કેમ શકો ? કારણ ૧૬વર્ષ વીતી ગયા છે. હકીમ હેરાન થઈ ગયા કે આખરે એ કયા રાઝથી પદડો ઉઠાવવાના છે.

પેલી વ્યક્તિએ કહ્યું આજથી ૧૬વર્ષ પહેલાં હું તમારી દુકાન પાસેથી પસાર થઈ રહ્યો હતો અને અહીં જ મારી કારનું પંકચર પડ્યું હતું. હું બહાર તડકામાં ઊભો હતો અને તમે મને જોયો તો કહ્યું સાહેબ દુકાનમાં આવીને બેસી જાવ. હું અંદર આવ્યો અને જોયું કે, તમે લોકોને દવા આપીને ફારિગ બેઠા હતા. એક નાની છોકરી તમારી પાસે આવીને કહી રહી હતી, બાબા ભૂખ લાગી છે, ઘરે ચાલો. મેં વિચાર્યું હું તમારી દુકાનમાં એમજ બેઠો છું ચાલો દવા લઈ લઉં અને કંઈક રકમ તમને આપી દઉં. મેં હકીમ સાહેબને કહ્યું અમારી શાદીને ૭ વર્ષ થયા અને ઔલાદથી મેહરૂમ છીએ. ઘણાં ઈલાજો કરાવ્યા પણ કોઈ ફાયદો થતો નથી. હકીમ સાહેબે મુતવજ્જે થઈ કહ્યું. અલ્લાહની રેહમતથી માયુસ ન થાઓ. અલ્લાહનો હુકમ હશે અને તેને મંજૂર હશે તો તે તમને ઓલાદથી જરૂર નવાઝશે. મેં કંઈક પૈસા કાઢ્યા અને તમને

કર્કલીઝના ફૂડ સ્ટોર અને રેસ્ટોરન્ટને લોવર હાઈજીન રેટ

૨૦૨૨ના વર્ષમાં કર્કલીઝ વિભાગમાં ઘણાં ફૂડ સ્ટોર્સ અને રેસ્ટોરન્ટ, ટેઈકઅવેની ફૂડ સ્ટાન્ડર્ડ અને હાઈજીન માટેની ચકાસણી થઈ હતી. જેમાં મોટી સંખ્યાના ફૂડ બીઝનેસ, રેસ્ટોરન્ટ અને ટેઈકઅવેને ફૂડ સ્ટાન્ડર્ડ એજન્સી મારફત ફક્ત એક સ્ટારની પુઅર રેટિંગ આપવામાં આવી હતી અને તેમને હેલ્થ સેફટી, ફૂડ હાઈજીન ફૂડ પ્રીપરેશનનું સ્ટાન્ડર્ડ સુધારવા માટે નોટિસ પાઠવવામાં આવી હતી.

આ પ્રમાણેની નિયમિત ચકાસણીથી ફૂડ સ્ટોર્સ, ટેઈકઅવે, રેસ્ટોરન્ટના ઉપર દબાણ લાવવામાં આવે છે જેનો એકંદરે ફાયદો આમ જનતાને જ પહોંચે છે કે જેથી તેમને સાફ સફાઈ, હેલ્થ સેફટી વગેરેનો લાભ પહોંચે છે. ફૂડ સ્ટાનડર્ડ એજન્સી તેમની ચકાસણી અને તપાસમાં ફૂડ કેવી રીતે તૈયાર કરવામાં આવે છે તેનો સંગ્રહ કેવી રીતે કરવામાં આવે છે, ફૂડ સેફટી મેનેજમેન્ટ અને ફૂડ ક્લીનીંગ અને કિચન વગેરેની સફાઈ અને ફૂડનો નીકાલ તથા અન્ય સફાઈ વગેરેને ધ્યાનમાં લેવામાં આવે છે અને પછી તેમને ફૂડ હાઈજીન રેટ આપવામાં આવે છે.

ભારતનો મુસ્લિમ સમુદાચ ભારે ચિંતામાં

ભારત ખાતે પ્રતિદિન મુસ્લિમો સામે જે આફતો આવી રહી છે તેનાથી ભારતમાં તો શું વિદેશમાં પણ લોકો ચિંતામાં છે. એ કહેવું પણ મુશ્કેલ છે કે આવતી કાલનો સૂરજ તેમના માટે કયી નવી મુસીબતના સાથે ઉગશે. ગયા માસમાં એક ટીવી ચેનલના ડીબેટમાં બીજેપીના નેશનલ પ્રવક્તા નુપુર શર્માએ મહંમદ પયગમ્બર સ.અ.વ.ના બારામાં અભદ્ર ટીપ્પણીઓ કરી જેનાથી પૂરા દેશના મુસ્લિમો વિરોધમાં ઉતર્યાં. આ માટે આવેદનો અપાયા, દેખાવો થયા પરંતુ સરકાર તરફથી કોઈ પગલા કે ધરપકડ જેવું કંઈ ન થયું.

૧૦દિવસ પછી અરબ દેશો અને અરબ દેશોના સંગઠનોએ કડું રૂખ અપનાવ્યું. તેમના દેશોમાં ભારતના રાજદૂતોને બોલાવી સરકાર તરફથી માફી અને નફરત ફેલાવનારાઓ ઉપર કાર્યવાહીની માંગ કરી. ઉપરાંત આ અરબ દેશોમાં ભારતના માલસામાનનો બહિષ્કાર અને વેપારી સંબંધો તોડવાની વાતો કરી. જેના કારણે બીજેપી સરકાર હરકતમા આવી અને તેમના આ પ્રવકતા અને અન્ય બીજી વ્યક્તિ નવીનકુમાર જિંદલને પાર્ટીમાંથી બરખાસ્ત કર્યા. પરંતુ તેમના ઉપર કોર્ટમાં કેસ કે અન્ય કાર્યવાહી કરવામાં ન આવી. આમ સરકારનું બેવડું વલણ છતું થયું.

ભારતના અનેક શહેરોમાં મુસ્લમાનોએ પ્રદર્શન કર્યું અને તેમાં ઘણાં મુસ્લિમોની ઘરપકડ થઈ. કેટલાયને જેલમાં પૂરવામાં આવ્યા અને તેમના ઉપર અમાનવીય વ્યવહાર પણ કરવામાં આવ્યો. જ્યારે કે કોઈ હિન્દુ સામે પગલાં ભરાયાં નહીં. ઉત્તર પ્રદેશમાં તો જાણે ત્યાંના મુખ્ય પ્રધાનજ સર્વોપરી હોય તેમણે સુપ્રિમ કોર્ટ કે રાજ્યકક્ષાની કોર્ટેને પણ નેવે મૂકી સંવિધાનનું ઉલંઘન કર્યું અને જે મુસ્લિમો આંદોલનમાં સામેલ હોય તેમાના કેટલાયેના ઘરો ઉપર બુલડોઝર ફેરવી તોડી નાંખવામાં આવ્યા. આ સમયે સવાલ ઊભો થાય છે કે શું આ પ્રકારનું વલણ કે કામગીરી ફક્ત મુસલમાનો સામેજ કેમ? પાર્લામેન્ટમાં કેટલાયે એમ.પી. અને અન્ય બ્યુરોકાટ ગુનેહગાર છે તો તેમના મકાનો ઉપર બુલડોઝર કેમ ફેરવાયા નથી? એવા અનેક પ્રશ્નો આજે કેટલાક તટસ્થ મીડિયા કે રીટાયર્ડ જજ પૂછી રહ્યા છે.

મોંઘવારી મચાવી રહી છે હાહાકાર

હાલમાં વિશ્વમાં મોંઘવારીએ હાહાકાર મચાવ્યો છે. ખાધ્યપદાર્થો અને પેટ્રોલ-ડીઝલના ભાવો અને ઈંધણના (ગેસ-ઈલેકટ્રીકના રેટો) ભાવો દિન પ્રતિદિન વધી રહ્યા છે. યુ.કે. પણ એમાંથી બાકાત નથી. સુપરમાર્કેટોમાં ઘણી વખત કેટલીક ગ્રોસરીની અછત જોવા મળે છે. અને તેમાં રશિયા-યુક્રેનનું યુધ્ધ કેટલાક અનાજ અને કૂકિંગ ઓઈલ સહિત પેટ્રોલ ડીઝલની અછત માટે જવાબદાર છે.

યુ.કે.ના લોકોનું જીવનધોરણ પણ કથળી રહ્યું છે. હાલમાં યુ.કે.ની ફડ સ્ટાન્ડર્ડ એજન્સીના (FSA) રિપોર્ટમાં ઈંધણના ભાવો અને પેટ્રોલના વધતા જતા ભાવોએ યુ.કે.વાસીઓની ચિંતા વધારી દીધી છે. આ રિપોર્ટમાં જણાવાયું છે કે, ઘણાં લોકો પહેલા કરતાં હવે વધુ ફડ બેન્કનો સહારો લઈ રહ્યા છે. રિપોર્ટ જણાવે છે કે, માર્ચ ૨૦૨૧માં ૧૦માંથી એક વ્યક્તિ ફૂડ બેન્ક ઉપર આધાર રાખતો હતો તેમાં વધારો થઈ દર ૬ વ્યક્તિઓ પૈકી એક વ્યક્તિ હવે ફૂડ બેન્ક પર આધાર રાખે છે. વળી તેમના ભોજનમાં પણ કટ ડાઉન કરે છે. કેટલાક કહે છે તેમણે એક વખતનું ખાવાનું પણ છોડી દીધું છે. આ પ્રકારની અસુરક્ષા ઓછી આવક ધરાવતા મોટી ફેમિલી, યુવાવર્ગ તથા એશિયન અને આફ્રિકન લોકોમાં વધુ જોવા મળે છે.
